AN ORDINANCE TO ALLOW PAYMENT OF CLAIMS PRIOR TO BOARD ALLOWANCE

WHEREAS, IC 36-4-8 and 36-5-4 lists various conditions which must be met prior to issuing warrants in cities and towns and whereas IC 36-4-8-14 and IC 36-5-4-12 allows a city or town board to adopt an ordinance allowing the city or town fiscal officer to pay certain types of claims prior to board allowance

WHEREAS, the Town Board of Ulen finds that the payment of such claims is necessary to ensure the receipt of uninterrupted services and goods for the Town of Ulen

NOW THEREFORE BE IT ORDAINED BY THE TOWN BOARD OF ULEN

SECTION 1. That the Clerk-Treasurer for the Town of Ulen shall be permitted to pay before board allowance certain claims as itemized in Section 3.

SECTION 2. That claims paid pursuant to Section 1 shall be approved by the Town Board at its next Board meeting following said payment

SECTION 3. Claims permitted to be paid by the Clerk-Treasurer prior to Board allowance shall include the following:

- a) monthly rubbish removal payments
- b) utility payments for water hydrants and street lights
- c) leaf removal including equipment rental and contract labor
- d) snow removal
- e) insurance premiums
- f) fire protection
- g) clerk-treasurer compensation
- h) legal advertising

SECTION 4. That payment of claims prior to approval shall be allowed until such time as the Board of the Town of Ulen rescinds such authority

SECTION 5. That provision of this ordinance take effect upon publication required by law and approval by the Board of the Town of Ulen
